

Cookie Statement

Effective Date: June 1, 2021

This Cookie Statement ("Statement") explains how Wazuh, Inc. and its subsidiaries and affiliates ("Wazuh", "we", "us", and "our") use cookies when you visit, interact with or use any of our websites, social media pages, online advertisements, marketing communications, and why we sometimes need to store these cookies. We will also share how you can prevent these cookies from being stored.

1. What are cookies

As is common practice with almost all professional websites, Wazuh uses cookies for its own website. When you visit any Wazuh online property, we may store or retrieve information on your browser, mostly in the form of cookies, which are defined as small files that are downloaded to your computer and used to improve your experience.

2. How we use cookies

We use cookies for a variety of reasons detailed below. Unfortunately, in most cases, there are no industry standard options for disabling cookies without completely disabling the functionality and features they add to a site. It is recommended that you enable all cookies if you are not sure whether you need them or not in case they provide a service that you use.

3. The cookies we set

- **3.1. Preferences cookies.** These cookies make it easier to navigate the site and improve your user experience. They basically allow our website to work properly (e.g. cookie permission settings, etc), but their absence should not prevent the site from working.
- **3.2. Statistics cookies.** Wazuh uses statistics cookies provided by trusted third parties. Third-party cookies you might encounter through this site include Google Analytics. This is one of the most widespread and trusted analytics solutions on the web. It helps us understand how you use our online properties and the ways in which we can improve your experience. These cookies may track things, such as how long you spend on the site and the pages that you visit. Wazuh uses this information to produce engaging content on a regular basis. - **3.3. Stripe cookies.** In the Wazuh Cloud Console, when you initially provide or update your payment information, we transmit it via an encrypted connection to our Payment Processor, Stripe. Stripe uses and processes your payment information in accordance with Stripe's Privacy Policy. We don't store your payment information.
- 3.4. reCAPTCHA. We use the reCAPTCHA service provided by Google LLC (Google) to protect your



submissions via internet submission forms on this site. This plugin checks if you are a person in order to prevent certain website functions from being (ab) used by spam bots. This plugin query includes the sending of the IP address and possibly other data required by Google for the Google reCAPTCHA service. For this purpose, your input will be communicated to and used by Google. However, your IP address is previously truncated by Google within member states of the European Union or in other states which are party to the agreement on the European Economic Area and is, as such, anonymized. Only in exceptional cases is a full IP address transmitted to a Google server in the United States and truncated there. On behalf of the operator of this website, Google will use this information to evaluate your use of this service. The IP address provided by reCaptcha from your browser shall not be merged with any other data from Google.

4. Tracking technologies

We engage third-party providers to serve marketing cookies that enable us to track and analyze usage, navigational, and other statistical information from visitors to the Site and to display advertisements on other websites. This information does not include Personal Information though we may reassociate this information with Personal Information we have collected when it is received. Marketing cookies are also used to track the performance of our advertisements and are employed by third-party advertising networks that we utilize. These advertising networks follow online activities of visitors to the Site and use this information to inform, optimize, and serve tailored advertisements on the Site or on other websites they visit that we believe would most effectively promote the Service to you. We also use third parties to collect information that assists us in other methods of "remarketing" our Service to visitors to the Site, including customized email communications.

5. Disabling cookies

You can prevent the cookies from being stored by adjusting the settings on your browser (see your browser Help to learn how to perform this action). Be aware that disabling cookies will affect the functionality of Wazuh online properties and many other websites you visit. Disabling cookies will usually result in disabling certain functionalities and features of a site. Therefore, it is recommended that you do not disable cookies.
